Continue up hill, approximately 2.6 miles, turn left onto 17th Street. Take first left into parking lot. The pool is on the left behind the soccer field.
- Facility:** Outdoor pool, 50 meters by 25 yards, 8 lanes, 2.5 meters per lane. Depth at Starting End: Between 6-15-1/2 feet. Depth at Turn End: Between 6-15-1/2 feet. Parking available and seating for 3,000 spectators. The indoor pool (25 yards by 15 yards) will be available for warm-up/cool down swims during the afternoon sessions. Swim venue includes: All areas enclosed in the indoor pool natatorium and the outdoor pool area. Daktronic electronic timing system. Facilities are accessible for swimmers with disabilities and they are encouraged to participate. The competition course has been certified in accordance with 104.2.2C(4).

Eligibility:

This meet is open to all swimmers who are currently registered with USA Swimming or registered with a USA Swimming recognized foreign federation, who have achieved the entry qualifying time standard or above in their respective age group on the events entered. A limited number of MHA swimmers may enter the meet below the qualifying standard. Swimmers may enter a maximum of 3 individual events per day, 8 individual events for the total meet. Swimmers must not be entered in the C Meet. **No on deck registration will be permitted.** All swimmers must be supervised by a USA Swimming certified coach at the meet. If they do not have one, they must report to the Clerk of Course or Meet Director prior to warm-ups to be assigned one.

Meet Limit:

12 & Under session is limited to the first 350 swimmers.

Entries:

Entry acceptance period begins: Noon, Wednesday, May 11th, 2011. NO EARLIER PLEASE! Early entries will not be accepted! Team Manager event file will be available for download on MHA website (www.mthoodaquatics.org) by April 20th, 2011. Events will be filled on a first-come, first-serve basis. Teams with Hy-Tek capability are strongly encouraged to submit a Commlink entry file (cfile01.cl2) or by zipped e-mail file.

Entries that require manual entry by MHA must be clearly legible. MHA will make every effort to correctly enter manual times, but are not responsible for data entry errors due to illegible entries. Hy-Tek Meet Manager Software will be used for the meet. Swimmers' ages as of 6/17/2011 and USA Swimming registration numbers must be included.

Mail the following to the Meet Entry Address:

a.) For Hy-Tek Entries:

1. Hardcopy of the Hy-Tek TM "Meet Entries Report."
2. Hardcopy of the Hy-Tek TM "Meet Entry Fee Report."
3. Full Payment (indicate which team if writing a personal check).
4. Master Entry Fee Summary (signed).

b.) If using the Meet Entries form (not using Hy-Tek), a hardcopy of the meet entry form legibly filled out and full payment (indicate which team if writing a personal check). Include the Master Entry Fee Summary (signed).

c.) **Please send entries as a separate file from the C Meet.**

d.) Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing racing starts or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Entries received after the Entry Deadline will not be accepted. Updates of entry times after the entry deadline will not be accepted. Entry times should be Long Course Meters (LCM) only. Short Course Yards (SCY) and Short Course Meters (SCM) qualifying times are to be entered at the LCM qualifying standard. Updates and/or "Adds" to e-mail text messages will not be accepted. **No phone entries will be accepted.**

DO NOT LEAVE ENTRIES AT THE POOL.

Please mark any courier delivered packages: "NO SIGNATURE REQUIRED".

Late entries (consisting of adds/changes for swimmers already entered in the meet) will be considered on a case by case basis at the discretion of the meet referee.

Entry Limit: Swimmers may enter a maximum of three (3) individual events per day (total of 9) individual events and up to two (2) relays for the meet. Relay entries are limited to A, B, and C for each team per relay event.

Entry Fees: \$6.00 Swimming Surcharge per swimmer (\$3.00 facility fee/\$3.00 OSI surcharge).
\$2.50 Individual Event Fee
\$9.00 Relay Fee

Entry Deadline: Entries must be received as follows:

- b.) Standard Mail Entries: Postmarked No Later Than Monday, May 30, 2011. Full payment and hardcopies of Hy-Tek information (previously submitted via e-mail) must be received prior to June 3, 2011.

Check-In and Scratches:

All events will be heat seeded.

400 FREESTYLE: This event may be limited to the fastest 8 heats depending on the meet timeline. Heats will be swum slowest to fastest.

Restrictions:

TOBACCO PRODUCTS OF ANY KIND, ALCOHOLIC BEVERAGES, AND GLASS CONTAINERS ARE NOT ALLOWED IN THE SWIMMING VENUE. NO SKATEBOARDS OR DOGS are allowed on the MHCC campus. Shaving is NOT permitted in the facility. **Only coaches, swimmers, and meet volunteers will be permitted on the deck.**

Rules:

Current USA Swimming, Inc. and Oregon Swimming, Inc. rules will govern this meet.

Timeline:

If the projected length of a session exceeds 4-1/2 hours, the Meet Referee, in consultation with Mt. Hood Aquatics, reserves the right to "double end" the meet (have starts from both ends of the pool).

Scoring:

Individual: 9-7-6-5-4-3-2-1 with ribbons to 8th place.
Relay: 18-14-12-10-8-6-4-2 with ribbons to 8th place.
Awards will be given for 1st, 2nd, and 3rd place Teams and Individual High Point.

Times:

12 & Under Warm-ups: 8:00 a.m.
Times Finals: 9:00 a.m.

Safety:

Current Oregon Swimming safety guidelines and warm-up procedures will be strictly enforced.

Timers:

Each team will be given timing assignments. Please encourage timers to report to the head timing area prior to the start of the meet.

Time Trials:

Time trial swimmers must be entered in the meet database to participate in time trials. Time trials will be held upon time permitting immediately following each session. Swimmers may enter a maximum of one (1) time trial per day per swimmer, not to exceed the total three (3) individual events per day limit. Each swimmer will provide timers and counter. Lanes with no timers will go unprotected. Entries must be turned into the Clerk of Course with fee (\$5.00/Individual) one hour before the projected end of the session.
